## **Union Man Appears on New** Speed TV Show, Wins \$2,000

## ■ Set to Premiere in February

Union resident Steve Webb, 27, recently "revved up" his bank account after winning on an episode of "Pass Time."

The show, which will be launched next month on the Speed Network, involves three contestants attempting to guess how fast 10 cars will run a quarter-mile track.

"I was visiting a (Ford) Mustang Web site that I go to all the time and there was a forum posted, looking for participants for a new TV show," Webb said. "I filled out an application online and they emailed me back and told me to show up in Memphis, Tenn."

Since the show was new, he debated making the trip or

"I didn't really know what to expect," he said. "I didn't think I would get on. I really had to think if the trip would be worth my time."

Webb decided to go and drove to Memphis, Tenn., in mid-November — a trip he said was "almost" a waste of time because he never got to

"They were taping for two days and ended up running behind due to some technical problems," he said. "Since they ran behind, they bought about four or five of us plane tickets to Florida for a live taping in December."

The episode was taped at Bradenton Motorsports Park in Bradenton, Fla.

Webb said of the three contestants, one is known as a "resident expert," who appears on every episode. Each contestant gets to ask each driver one question about the

"Basically, the driver pulls the car up to the starting line and introduces it," he explained.

Questions generally were about the mechanics of the automobile, according to Webb.

"After the driver answers the question, you had to enter in how fast you think the car's going to run," he noted. "The driver takes the car down the track and the contestant with the closest speed wins. At the end, the winner takes the other two contestants' money too."

The 30-minute episode features host Brett "The Big Schwag" Wagner, who also was the narrator for "Monster Garage" which appeared on the Discovery Channel.

The show was originally titled "Name That Time and Tune," until it was picked up by a network, Webb said. Rich Christenson is the creator. He also created the show "Pinks," which appeared on the Speed Network.

Webb has years of experience in racing. He began learning about drag racing at the young age of 10 with the guidance of his father, Bill.

"I started out as 'crew chief' and was actually racing when I was 16, he said. "My dad handed me the keys and I just never gave them back."


Webb raced for about seven years and gave it up until recently.


