

INSTALLATION INSTRUCTIONS

2005 FORD MUSTANG SUBWOOFER ENCLOSURE

PARTS LIST


- (1) Top "L" Bracket
- (2) 8mm x 25mm Hex Bolts
- (2) Lock Washers

- (1) Bottom Flat Bracket
- (4) 3mm x 16mm Phillips Screws
- (2) Wing Nuts (Used for Shaker 1000 only)

ATTACHING BRACKETS

Assemble the enclosure mounting brackets as shown in Figure 1.

- The "L" bracket mounts to the top of the enclosure. Use a Phillips head screwdriver and (2) supplied 3mm x 16mm Screws to fasten the bracket. Threaded fittings are molded into the surface of the enclosure for easy installation. (See Figure 1)
- 2. The "Flat" bracket mounts to the bottom side of the enclosure. Use the (2) remaining 3mm x 16mm Screws to fasten the bracket. (See Figure 1)



ENCLOSURE INSTALLATION


NOTE: If the vehicle is equipped with a "Shaker1000" Ford Mach Sound System, the Factory Subwoofer /Amp Rack assembly must be removed. See next section: "Mach Audio Shaker 1000 Removal / Installation".

PREPARING THE MOUNTING POINTS:

- 1. Pull back liner material from bottom right corner of the trunk.
- 2. Remove the round protective seal (sticker pad) near the spare tire well to reveal the Factory threaded screw hole.
- 3. Reposition the trunk liner and use a punch or pick tool to punch through the liner material over bolt hole location.
- 4. Pop out the carpet fastener from the top right rear corner of the trunk area. Removal of this popper will reveal the top threaded mounting hole.

ENCLOSURE INSTALLATION:


- Once the mounting points are ready, place the sub enclosure on the trunk floor and connect the speaker wire from your Sub Amplifier. (RED Terminal = Subwoofer Positive, BLACK Terminal= Subwoofer Negative)
- 2. Position the sub enclosure into the rear right corner of the trunk aligning the holes in the brackets with the factory bolt hole locations.
- 3. Use the (2) supplied 8x25mm bolts and lock washers to secure the sub enclosure to the vehicle. (See Figure 2)



MACH AUDIO (SHAKER 1000) REMOVAL / INSTALLATION

ENCLOSURE REMOVAL / INSTALLATION:

- Using an adjustable wrench, remove 3 retaining nuts located near the front, top and rear of the MACH Audio Sub enclosure/amp rack.
- 2. Unplug and remove the entire assembly.
- Leave the top and rear Factory Ford mounting studs in place as these will be used to fasten the EFX enclosure.
- Use the lock washers and wing nuts provided to mount the sub enclosure to the Ford studs. (See Figure 3)
